Haj amount payable by the pilgrims for Haj 1443 (H) - 2022 is indicated tentatively as per embarkation point in the Table below as per cost inputs received so far.

Note:- i) Before paying the Balance Haj Amount Pilgrims must verify the exact amount payable by them on

Haj Committee of India website <u>hajcommittee.gov.in</u>. / hajcommittee.com. Payment challan can also be generated from the website,

ii) Amount payable for infants if allowed is given in Annexure-I.

iii) Shia Pilgrims embarking from Ahmedabad, Hyderabad, Kolkata and Mumbai landing at Jeddah Haj Terminal and opting for JOHFA as MEEQAT, are required to pay extra **SAR 177.10/- = Rs.3,666/- per pilgrim.**

Shia Pilgrims embarking from Bengaluru, Cochin, Delhi, Guwahati, Lucknow and Srinagar landing at Madinah Haj Terminal and opting for JOHFA as MEEQAT, are required to pay extra SAR 155/- = Rs.3,209/- per pilgrim.

iv) Pilgrims opting for Qurbani (Adahi) Coupons of IDB, will have to pay an additional amount of Rs.16,747/-.

v) The break-up of the total amount in Saudi Arabia is given in **Annexure –II which excludes Air** Fare and other **Miscellaneous expenditure.**

vi) Last date for payment of the Haj Amount is 31.05.2022. No further extension will be granted. Flights are likely to start from 04.06.2022. Pilgrims will not be allowed to board the flight if all dues are not paid.
