The dates mentioned in the Action Plan need to be adhered strictly by the State/UT Haj Committees and all other agencies involved in Haj Management as any delay in the calendar of the activities would hamper the overall Haj Management. It is further expected that all agencies involved shall strive to work in a time-bound manner to provide better and upgraded services to Haj pilgrims and make Haj – 2022 a success.
