### **ANNOUNCEMENT FOR HAJ 1443 (H)- 2022 (C.E.)**

- ❖ Haj-2022 will take Place under Special Circumstances with Special Norms, Rule & Regulations, Eligibility Criteria, age Restrictions Health & fitness requirement and relevant condition as mandatory by Kingdom of Saudi Arabia amid Covid-19.
- ❖ The Process of application for Haj-2022 through Haj Committee of India shall commence online **from 01.11.2021 and will conclude on 31.01.2022.**
- ❖ The applicants should have taken two doses of approved Covid-19 vaccines, at least one month before departure for Haj-2022.
- ❖ The Entire process of Haj Application for Haj-2022 is provisional subject to final Guideline of KSA.
- ❖ Haj Application can be filled online only at website of Haj Committee of India i.e. [http:// hajcommittee.gov.in](http://hajcommittee.gov.in) and through "HCOI" Mobile App. Payment of Registration Fee is to be deposit online.
- ❖ Haj Application will be accepted online only. Applicant must read the Guideline /Undertaking Carefully before filling Haj Application. Pilgrims must upload first & last page of Machine readable Passport, latest Passport size Photograph, copy of cancelled cheque of Cover Head and copy of address Proof.
- ❖ Applicant can fill their Haj Application online themselves or through Haji Suvidha Kendra at respective State / UT Haj Committee offices as per their convenience.
- ❖ Following changes /feature will be Hallmark of Haj -2022.
  - Age Limit upto 65 years.
  - Cover size Max. Five (5).
  - Haj Journey 36-42 days.
  - Ladies without Mehram in age group 45-65 yrs. & groups of 4-5 Pilgrims.
  - Ten (10) Embarkation points for departure of pilgrims.
  - No Provision of NRI's due to Covid-19.
  - Advance Haj Amount is ₹.81,000/- only in respect of provisionally Selected pilgrims.
  - Machine readable Passport validity upto 31.12.2022.
